Momoyama period (1573-1615), Japan

Miyuki: the imperial outing and hunt 1600–10 pair of six-fold screens (*rokkyoku byobu*), colour and gold on paper 168 x 366 cm (each)

purchased with the generous assistance of Andrew and Hiroko Gwinnett

Inspired by an episode of the classic Japanese novel *Tale of Genji*, this spectacular pair of six-fold screens was created in the early 17th century by an artist of the celebrated Kano School. *Tale of Genji* relates the events and intrigues of Heian-period (794–1185) aristocrats, and it remained a popular theme in the art of the later Momoyama period (1573–1615).

The screens capture the pageantry of Japanese court life. The magnificent procession is a royal

hunting party travelling to a shrine at Oharano, west of Kyoto. Mounted guards, costumed courtiers and attendants bearing large parasols accompany the emperor's carriage. A crowd has gathered to enjoy the colourful spectacle. The right screen shows the chaos of the hunt, with falconers, men on horseback and courtiers in ornate dress pursuing deer, pheasants and wild boar.

While the narrative describes an earlier time, this scene is set in the 17th century, with all characters dressed in exquisite Momoyama-period dress and with blossoming cherry trees that reflect the growing popularity of cherry blossom viewing.

Purchased with the assistance of Andrew and Hiroko Gwinnett, generous supporters of Japanese art in Australia, *Miyuki: the imperial outing and hunt* enhances the Gallery's small but fine collection of Japanese screens.

An exciting new acquisition of contemporary Asian art is *Clear lotus*, a huge clear vinyl inflatable flower by renowned Korean artist Choi Jeong Hwa. Born in 1961, the artist began his career as a painter but, by the early 1990s, had shifted from painting to installation, video and sculpture, particularly the inflatables for which he is now famous.

Many of Choi Jeong Hwa's more recent works are gigantic floral-form inflatables, including lotus blossoms in black, white, acid yellow and transparent plastic. His blow-up lotuses have attracted considerable international attention since their first appearance in the Korean Pavilion at the 51st Venice Biennale in 2005. The motorised *Clear Lotus* magnificently inflates and opens, then deflates limply before the cycle begins again. While much of his work can be interpreted as communicating concerns about waste, consumer society, globalisation and other contemporary issues, the artist consciously avoids such discussion. Rather, Choi celebrates the peculiar beauty of synthetic materials and everyday objects with flippant lightness and deliberate ambiguity of purpose.

Through the Gene and Brian Sherman Contemporary Asian Art Fund, long-serving Foundation member Dr Gene Sherman has directed her generous financial contributions towards building a national collection of significant works by Asian contemporary artists with strong international reputations.

The National Gallery of Australia Foundation, a company limited by guarantee under the Corporations Law, is a non-profit organisation established to support the National Gallery of Australia.

The principal objectives of the Foundation are to:

- maintain, improve and develop the national collection of works of art owned by the National Gallery of Australia
- promote, maintain, improve and develop the National Gallery of Australia
- support the development and conduct by the National Gallery of Australia of travelling exhibitions of works of art
- raise money to achieve these objectives.

A popular new acquisition in the national collection of Indian art is the charming 11th–12th century sculpture of Nandi, the sacred bull. The large stone image of the mount or vehicle of Shiva, the Hindu god of destruction and creation, is a superb example of the sculpture of India's Chola dynasty (9th–13th centuries).

The major Hindu deities each have their own specific vehicles (*vahana*) on which to ride, including Vishnu on the Garuda bird, Ganesha on

a large rat and Durga on her lion. Nandi is one of the most adored of the vehicles. The sacred bull is not only the devoted companion and guardian of the great Shiva but, as his name—giver of delight and joy—suggests, an object of worship in his own right.

The south Indian sculpture in the form of a humped Brahman bull is very appealing. Depicted in ceremonial ornamental finery, with legs tucked under and tail wrapped around its smooth round body, Nandi gazes serenely back at the viewer with soft melancholy eyes.

This acquisition was made possible through the generous support of long-standing National Gallery of Australia Council member Roslyn Packer AO. We are very grateful for her continued support in building Australia's finest collection of Asian art.

Chairman's report

I am pleased to present the National Gallery of Australia Foundation's Annual Report 2008–09, which records a successful year for the Foundation with \$1.33 million of donations. In addition to cash donations, the Foundation assisted the Gallery in securing donations of works of art in excess of \$8 million; this figure is reflected in the National Gallery of Australia Annual Report.

This year, we celebrated the 20th anniversary of the Foundation. Over the last 20 years, through a number of campaigns and appeals and many individual acts of benefaction, the Foundation has successfully raised funds to assist with Gallery programs and acquiring works of art for the national collection.

Major donations and gifts for 2009

During the year, through the generosity of a number of donors, the national art collection has been developed and further strengthened. I acknowledge the assistance of the following major benefactors.

Mrs Roslyn Packer AO generously donated towards the acquisition of The sacred bull Nandi, vehicle of Shiva Chola dynasty (9th-13th centuries), which is an important acquisition for the collection of Asian art and is on display in the Indian gallery. Mr Andrew Gwinnett and Mrs Hiroko Gwinnett, who have been most generous donors to the development of Japanese art in the national art collection, have also donated this year to acquire a pair of Japanese screens, Miyuki: the imperial outing and hunt, from the Momoyama period (1573–1615). Through the generous assistance of Mr Terry Campbell AO and Mrs Christine Campbell, the Gallery was able to acquire Frederick McCubbin's painting 'At the falling of the vear' 1886. Mr Brian Sherman AM and Dr Gene Sherman assisted the Gallery to acquire Clear lotus 2009; this contemporary sculpture was included in the exhibition Soft sculpture, on display at the Gallery from April to July 2009.

The Foundation is very grateful to Mr James Erskine and Mrs Jacqui Erskine for their most generous donation of John Olsen's *The Murray running into Lake Alexandrina* 1975, Antony Gormley's *Angel of the North (life-size maquette)* 1996, the work *Body marks* 2001 by Midpul (Prince of Wales) and Paddy Bedford's *Middle Brand* 2001.

In addition, the Gallery received very generous gifts of works of art from Mr Gordon Brown, Mr John Gollings, Ms Marion Kaselle, Mr Kevin Lincoln, Mrs Jennifer Manton, Mr Rupert Myer AM and Mrs Annabel Myer, Dr Margaret Olley AC, The Australian Embassy in Washington, Professor Bernard Smith and Mr Imants Tillers.

Thanks are also expressed to the Yulgilbar Foundation for the generous support provided through the National Gallery of Australia's Foundation to assist with the children's activity room located in the major summer exhibition for 2009, *Masterpieces from Paris: Van Gogh, Gauguin, Cézanne and beyond*, which will showcase Post-Impressionist treasures from the Musée d'Orsay.

25th Anniversary Gift Program

A major recent achievement was the role that the Foundation played in assisting the Gallery to exceed the goal of the 25th Anniversary Gift Program to secure more than \$25 million in gifts in the form of works of art, donations, bequests and corporate sponsorship. In December 2008, the program was completed with over \$26 million secured.

I sincerely thank all participants who contributed to this program and, in particular, acknowledge the generous support provided by Mrs Roslyn Packer AO, Mr Ray Wilson OAM and the late Mr James Agapitos OAM, Dr Margaret Olley AC, Mr Ben Gascoigne and the Gascoigne family, the Honourable Mrs Ashley Dawson-Damer, Mr Harold Mitchell AO and Mrs Bevelly Mitchell, Mr John Wylie AM and Mrs Myriam Wylie, Mr Sidney Baillieu Myer AC and Mrs Sarah Myer, Mr Rupert Myer AM and Mrs Annabel Myer.

The Gallery continues to benefit from the generous support provided by BHP Billiton for *Australian Indigenous Art Triennial: Culture Warriors* and National Australia Bank for the National Australia Bank Sculpture Gallery.

National Gallery of Australia Council Exhibitions Fund

I thank my fellow Council members who donated through the Foundation to the National Gallery of Australia Council Exhibitions Fund. During 2008–09, the fund supported the exhibitions *Gods, ghosts and men: Pacific arts from the National Gallery of Australia, Picture paradise: Asia– Pacific photography 1840s–1940s.*

The fund also supported the travelling exhibition Ocean to Outback: Australian landscape painting 1850–1950, which toured regional galleries in all states and territories, with the benefit of sponsorship support provided by Mr Ken Cowley AO and R.M.Williams, The Bush Outfitter.

Gala dinner and weekend 2009

Proceeds from this most successful event raised funds to assist in the acquisition of the Degas pastel *Woman bathing (Femme á sa toilette)* c 1880–85. Major funding to secure this work was obtained through the Orde Poynton Bequest. Degas was the great artist of intimate modern life and the most important artist of the pastel medium in the nineteenth century; the Gallery was extremely fortunate to secure this pastel, the first for the national art collection.

Masterpieces for the Nation Fund

The annual Masterpieces for the Nation Fund continues to build on the success of past years. This year, through the generosity of our donors, the Gallery has been able to acquire Tom Roberts's painting *Shearing shed*, *Newstead* 1893–94 for the national art collection.

Founding Donors 2010

In June 2009, the Foundation initiated the Founding Donors 2010 program to celebrate the opening of the new entrance and additional display spaces in 2010. The program aims to raise \$1 million in cash donations by June 2010, through the assistance of 100 donors contributing at least \$10000 each. The funds raised will assist in acquiring of works of art for the new galleries and display spaces. I am pleased to report that as at 30 June, we have already raised over \$100000.

Gallery building program

In December 2006, the Australian Government approved expenditure to commence a project to refurbish and extend the National Gallery of Australia building.

This project addresses a range of pressing needs in relation to the Gallery building, including enhanced collection display space (primarily for Aboriginal and Torres Strait Islander art) and improved arrival and entry facilities. This is the first increase in the permanent collection display space since the original building opened in 1982. The structure for Stage 1 South Entrance and Indigenous Galleries project is nearing completion; following the installation of services and fit-out, the new building will open in 2010.

The new ground level entrance will include a dedicated area for *The Aboriginal memorial* 1987–88, one of the most important works of art in the national art collection. Appropriately, this impressive installation will be the first work of art visitors see as they enter the Gallery.

The extension includes 10 new galleries for Indigenous Australian art, which will connect with the existing galleries on the main level. These new galleries are each designed to accommodate the needs of specific types of Indigenous art.

The Stage 1 building project also includes the significant external *Skyspace* sculpture designed by renowned American artist James Turrell, which will be a feature of the new garden on the Gallery's south side. Key refurbishments to the existing building, which are also part of this building program, will be opened by the end of 2009, including a new gallery to house Sidney Nolan's *Ned Kelly series* and new spaces for photography, costumes and jewellery.

Constitutional changes

In February 2009, a general meeting of the National Gallery of Australia Foundation amended the

constitution to create a new level of membership styled 'Founding Benefactor', which acknowledges the significant contributions made by members who have donated more than \$2 million. In addition, the constitution was amended to increase the base membership level to \$1000 for ordinary members and, subject to the *Corporations Act 2001*, to allow the Board to vary or modify the categories of membership of the Foundation.

National Gallery of Australia Bequest Circle

In November 2008, the Foundation launched the National Gallery of Australia Bequest Circle and, at the same time, Mr Ray Wilson OAM formally announced a major bequest of \$2 million to the National Gallery of Australia on behalf of himself and the late Mr James Agapitos OAM.

The National Gallery of Australia Bequest Circle provides formal acknowledgment of bequest supporters during their lifetime and gives potential and existing bequest supporters a unique opportunity to develop a closer relationship with the Gallery.

I am pleased to acknowledge our current Bequest Circle members: Mr Ray Wilson OAM and the late James Agapitos OAM, Mr Andrew Lu, Mr Richard Gate, Mrs Mary Alice Pelham Thorman, Mr Gavan Bromilow and Mrs Robyn Megson.

American Friends of the National Gallery of Australia

I particularly acknowledge the generous grant made by the American Friends of the National Gallery of Australia Inc in May 2009. 

John Gollings

Under the Cultural Gifts program, the Gallery acquired 60 large colour photographs of Papua New Guinean cultural gatherings called sing-sings. A gift from the archive of renowned Melbourne photographer John Gollings, the *New Guinea Suite* images are modern colour pigment prints on the highest quality archive paper. Gollings produced the images by scanning colour negatives that he had from several trips to Mount Hagen, Morobe and Goroka in Papua New Guinea in 1973 and 1974. Gollings had acted on suggestions by his former lecturer Professor Neville Quarry (then at Lae University) to photograph the dance styles and body decorations at sing-sings.

Gollings stayed with the parents of Quarry's Papuan students. He saw their preparations for the *singsings* and travelled with them to the shows. Gollings was inspired by the manifestation of ancient cultural practices in the performances. But rather than detailed ethnographic reportage, Gollings used an array of camera and film technologies, creating edgy and expressive photographs.

The quest for an interpretative, animated and dramatic realisation of the world through photography would shape Gollings's subsequent career. He has spent the last four decades photographing ancient and modern architecture across Australia, Asia and America.









Tracey Moffatt

Tracey Moffatt is an Indigenous Australian artist born and raised in Brisbane by foster parents. She now works between her base in New York and her homeland and is internationally renowned as an artist and film-maker.

As in several other series, Moffatt appears in each of the 12 works of art in *First jobs* 2008; she has added her own image into old photographs, which she sourced with great difficulty to match or evoke the places she worked as a teenager and art student in Brisbane from 1975 to 1984. The photographs are almost fluorescent—Moffat has commented that the colours recalled the candy she couldn't afford as a child.

First jobs seems to evoke nostalgia, and every stop along the young artist–pilgrim's way triggers memories for her audience about their own first jobs—which are rarely given their due as formative experiences. Yet, the perfect flat colours and images, in the end, rather disturb and niggle at the viewer, prompting reflections on how much these early experiences might also limit the path ahead.

This generous gift by Rupert and Annabel Myer has already captured the imaginations of many visitors to the Gallery and complements the Gallery's collection of works by this significant Australian artist.

Frederick McCubbin



From 1885 to 1886, Frederick McCubbin painted alongside Tom Roberts at the artists' camp at Box Hill (near Heidelberg). It was an ideal place to work because it allowed them easy access to the bush during the weekends and was a short train journey from Melbourne, where they worked during the week. They were soon joined by other artists, including Arthur Streeton, Charles Conder and Jane Sutherland.

During 1886, both McCubbin and Roberts painted outdoors in front of the motif, using a limited range of colours (predominantly greens and browns). McCubbin's '*At the falling of the year*' 1886, in its freshness and immediacy, close viewpoint and tonal palette, shows the advances that McCubbin (and Roberts) made in Australian landscape painting. It is radically different in composition and technique from the wide panoramic views of earlier Australian landscape painters. In works such as this, McCubbin sought an intimate, naturalistic approach to the bush, capturing the play of light and shade in the landscape. The breadth of his vision is evident—as is his deep understanding of nature.

Purchased with the assistance of Terry Campbell AO and Christine Campbell, '*At the falling of the year*' complements the Gallery's already outstanding collection of works by this iconic Australian artist.





J Miller Marshall

Fossicking for gold 1893 depicts a mining scene at Creswick, close to the goldfields of Ballarat, Victoria. For several weeks in the summer of 1893, English-born Australian artists J Miller Marshall and Walter Withers ran *plein-air* painting classes at Creswick and they likely worked side by side. Withers painted a similar work (also in the Gallery's collection), and the comparison between this painting with that of Withers yields insights into the differences between the way the artists handled paint and approached composition. Both made their own interpretation of this scene of two miners (probably based on models) conversing before a rock face—one miner standing with his shovel astride his shoulder and the other seated.

Miller Marshall was most recognised for his watercolours, but was also proficient in oil painting. He exhibited at the Royal Academy in London and arrived in Australia in the late 1880s. It is most likely that he came to Victoria in search of gold but stayed for art. Among his students were the brothers Percy and Lionel Lindsay.



Tom Roberts

Selected for the 2009 appeal for the Masterpieces for the Nation Fund, *Shearing shed, Newstead* c 1894 is a significant and intimate work by Tom Roberts that makes a statement about the Australian outback. It is one of his most compelling impressions.

Between 1889 and 1898, Roberts spent much of his time visiting rural properties and painting works of a national character. One of the places he visited frequently during the mid 1890s was Duncan Anderson's property, Newstead, near Inverell in the New England tablelands of New South Wales. It was there that he painted *Shearing shed*, *Newstead* during the summer of 1893–94.

He gave the painting to Anderson, possibly as a present during the festive season. It is inscribed 'Tom Roberts to DSA', with the ideogram of a bulldog, which refers to Roberts's nickname. The shed had been built by Anderson's parents for a larger Newstead, which was divided in two in 1883.

Shearing shed, Newstead is a powerful rural image of sunlight, heat, woolshed and sheep. Through the glare on the roof of the shed and the dust rising from the parched ground of the high-summer landscape, Roberts created a feel of the heat, the quietness and the blinding light. He created an experience of the Australian bush.



Stephen Bowers

This large and commanding ceramic platter shows Stephen Bowers's characteristic witty narrative realised through his complex visual composition and formidable underglaze illustration and painting skills.

While the immediate appeal of this work is its complex painted decoration, it rises above flat collage through the transformative process of ceramics as its clay body, glazes and underglaze paint colours fuse into a unified object of great visual density and presence. Merging into the mannered Chinoiserie of the background are the painted fragments of Australian flora and fauna, well-known characters from Australian comics of the 1930s and Sydney landmarks such as the Opera House, Luna Park and the Harbour Bridge. With this work, Bowers links us to the role that ceramics can play in defining our intimate and domestic experiences of place, time and memory.

Bowers was born in 1952 in Katoomba, New South Wales. He trained in Adelaide, South Australia, where he maintains his studio practice and plays a key role in the promotion of contemporary Australian craft as Managing Director of the JamFactory Contemporary Craft and Design Centre. His work links to a long tradition of surface design and visual narrative within Australian commercial and studio ceramic practice.

The acquisition of this spectacular contemporary Australian work was made possible by the Meredith Hinchliffe Fund.



Robert Rooney

Painter, photographer and art critic Robert Rooney has long been preoccupied with the imagination of the child—first revealed in a series of screenprints, linocuts and etchings produced in Melbourne during the 1950s. Many of these early prints explore the innocence of childhood in images of children at play or lost in thought. Some were included in Rooney's 1956 anthology of children's folk rhymes *Skipping rhymes*. During the 1960s, Rooney was best known for his paintings derived from mass-media products such as cereal packets and knitting patterns. He is also feted for his experimental serial photographs. Rooney returned to the simplicity of children's art in the 1990s with a series of richly saturated paintings that looked at the shared abstraction in Modernism and children's art. In 2001–02, he published a series of prints on 'School Arts' at the Australian Print Workshop, before creating a critically successful series of paintings based on obscure children's books. *Poet* 1958 is one of nine similarly themed works that Rooney gave the Gallery in 2008, along with three prints from *The Pilkington prints* 1980.

Born in Melbourne in 1937, Rooney exhibited works in the seminal exhibition *The Field* at the National Gallery of Victoria in 1968.

New Zealand artist Colin McCahon became interested in printmaking during the 1950s. In 1957, he collaborated with poet John Caselberg on a project that combined his love of the local landscape with his interest in the impact of text in art. *Van Gogh poems* contains five offsetlithographs based on Caselberg's verses (previously published in *The sound of morning*, Pegasus Press, 1954). However, after McCahon completed the prints, Pegasus Press declined to release the poems for republication. Subsequently, the folio was not exhibited until 1971 at Barry Lett Galleries, Auckland.

Born in 1919, McCahon is the most influential painter in New Zealand's history. He studied art during the 1930s and supported his family through seasonal work such as fruit picking, labouring and cleaning. A cleaning position at the Auckland City Art Gallery in 1953 led to a permanent staff position. By 1964, McCahon had exhibited at the gallery and internationally, and had begun lecturing in painting at the Elam School of Fine Arts, University of Auckland. McCahon became a full-time painter in 1971 but ceased to produce work in 1980 due to debilitating illness.

Gordon H Brown's generous gift of *Van Gogh poems* will enhance the National Gallery of Australia's already strong holdings of the McCahon's work.



Bert Flugelman

Bert Flugelman is one of Australia's most significant senior sculptors. He is widely known for his largescale steel geometric sculptures situated in the public sphere in urban and rural environments. Throughout his long career, he has been an important teacher and advocate of sculpture.

Double spiral with graffiti 2008 is an outstanding example of Flugelman's recent sculpture and continues his long-standing interest in geometric forms. The composition of this work is based on circles and triangles—simple shapes that embody universal and timeless qualities. Created from stainless steel, the balanced form of the triangle is set against the dynamism of the spiral. The inner sides of the sculpture are highly polished with a mirror finish, while the outer edges bear the artist's expressive patterns or 'graffiti'.

Polished stainless steel is one of Flugelman's preferred sculptural mediums as it animates the surface of the sculpture by making it responsive to its environment and to people, reflecting the everchanging light conditions and movement of the viewers. The mirror finish also serves to confound our visual perception of the solidity of the sculptural form, creating a sense of the work being visually 'light', dynamic and constantly in motion.

Takahiro Kondo

The ceramicist Takahiro Kondo was born in Japan in 1958, and lives and works in Kyoto. Kondo is a 3rd-generation potter whose grandfather, Yuzo Kondo, was a Living National Treasure. He gained a literature degree from Hosei University in 1982, completed training in ceramics at the Kyoto Ceramics Training School and the Kyoto Industrial Research Institute in 1986. In 2003, he was awarded a Masters of Design and Applied Arts at the Edinburgh College of Art. His work is held in a number of international museum collections.

Kondo explores the theme of water in his porcelain work. He has developed a unique repertoire of glazes and overglaze effects of silver, gold and platinum 'droplets' to achieve a beaded effect, which he describes as 'rain frozen through fire'. This hand-built work, with its sharp folds capped by a characteristic cast glass cover, is a typical Kondo architectonic form of great presence, crystalline beauty and calm. A gift of Lesley Kehoe Galleries, this is the first work by Kondo acquired by the Gallery. Its acquisition broadens the national collection of contemporary ceramics by Japanese artists, creating relationships with abstract and functional works by artists such as Mitsuo Shoji, Jun Kaneko and Sueharu Fukami.






Edgar Degas

Dr Margaret Olley AC is one of Australia's most respected artists, as well as a generous philanthropist to the arts. Her support over a number of years has enabled the Gallery to acquire major works that would otherwise be out of reach. Late last year, Dr Olley gave the Gallery an important Edgar Degas drawing, *Dancer in fourth position* (*Danseuse en quatrième position*) c 1885. Olley was inspired to give the drawing to the Gallery on the occasion of the first ever Degas exhibition in Australia, *Degas: master of French art* (12 December 2008 – 22 March 2009).

From the 1870s onwards, Degas turned frequently to the subject of the ballet. Initially his ballet compositions were of performances on stage. Then the artist approached his subject more directly, creating images of dancers in class, practising alone, dancing together or resting and chatting. *Dancer in fourth position* depicts Degas's fascination with ways to depict movement. The artist captures the dynamism of the dancer in a series of charcoal lines surrounding the arms and legs—searching for the most effective position for the dancer's body.

Dancer in fourth position is an important addition to the small but important collection of Degas monotypes, prints and drawings at the National Gallery of Australia.



Edgar Degas



One favourite subject of Edgar Degas was the female bather. In *Woman bathing (Femme à sa toilette)* 1880–1885, we see a nude figure seated on a bidet, her face shown in a silhouette against the light flooding through the drawn curtains of a boudoir. Despite its daring subject matter, Degas's depiction of this nude is one of intimacy and of tenderness.

At the time of its execution, Degas was particularly taken with working in pastel. The medium not only

allowed the artist to emphasise the linear qualities of his compositions but enabled him to infuse his subject with colour, texture and patterning. Degas was to become an outstanding exponent of pastel drawing in French art of the 19th century.

Woman bathing originally belonged to Degas's brother René De Gas and, since then, has been owned by a series of notable collectors in the French art world before being purchased by Yves Saint Laurent and Pierre Bergé in May 1987. The National Gallery of Australia was able to acquire such an important work with the combined benefaction of the late Orde Poynton AO, CMG, and the generosity shown by the supporters of the National Gallery of Australia Foundation's Twentieth Anniversary Gala Dinner in March 2009.



Max Beckmann

Firsthand experience of the horrors of the First World War deeply affected the German artist Max Beckmann and proved to be a catalyst for a radical change in his subject matter. The futility of war and subsequent malady of modern life spurred the artist to produce works that delivered sharp social comment.

Women at their toilette 1923 depicts two prostitutes undressing and washing—a presumably post-coital procedure. The women appear bored and detached, moving through their daily tasks as though striking a series of robotic poses, avoiding eye contact with the viewer and with each other. Despite the clandestine nature of the scene and their scantily clad appearance, the prostitutes are without erotic charge. Beckmann has deliberately constructed a scene that is so lacklustre in sensuality that it functions to elicit only pity from the viewer. The image is a sardonic comment on society's demise: contemporary life offering the individual only alienation and moral ruin.

As one of only 19 woodcuts created by the artist, *Women at their toilette* can be seen as part of a powerful component of the artist's printmaking oeuvre. The acquisition was made possible by the Poynton Bequest, which continues to support the Gallery in building an outstanding International Prints, Drawings and Illustrated Books collection.

The Foundation recorded a surplus of \$1,388,621 in 2008/09 (2007/08: \$2,064,751) before it made donations to the National Gallery of Australia. The donations consisted of funds used by the National Gallery of Australia to develop the national collection of works of art and to support the National Gallery of Australia and its travelling exhibition program. The activities of the Foundation for the 2008/09 year resulted in an operating surplus of \$300,800 (2007/08: \$152,005) after donations of \$1,087,821 (2007/08: \$1,912,746) were made to the National Gallery of Australia.

Dividends

The Foundation is a company limited by guarantee. The Foundation is precluded by its Memorandum of Association from paying a dividend to its members.

Significant changes in the state of affairs

There was no significant change in the state of affairs of the Foundation during the year.

1. STATEMENT OF SIGNIFICANT ACCOUNTING POLICIES

The National Gallery of Australia Foundation (the Foundation) is a company limited by guarantee, incorporated and domiciled in Australia. The significant policies which have been applied in the preparation of the financial report are:

(a) Basis of Preparation

The financial report is a general purpose financial report which has been prepared in accordance with Australian Accounting Standards, Australian Accounting Interpretations, other authoritative pronouncements of the Australian Accounting Standards Board and the *Corporations Act 2001*.

The financial report is presented in Australian dollars.

The financial statements are prepared on an accrual basis and in accordance with the historic cost convention and except where stated no allowance is made for the effect of changing prices on the results or the financial position.

The accounting policies set out below have been applied consistently to all periods presented in the financial report and have been applied consistently by the Foundation.

(b) Revenue Recognition

Interest revenue is recognised as it accrues. Donations and resources received free of charge are recorded as income at the date received.

(c) Cash and cash equivalents

Cash and cash equivalents includes notes and coins held and any deposits in bank accounts with an original maturity of 3 months or less that are readily convertible to known amounts of cash and subject to insignificant risk of changes in value. Cash is recognised at its nominal amount.

(d) Receivables

Receivables include accrued interest income on term deposits where accrued interest represents interest income to be received.

(e) Impairment of Financial Instruments

Financial assets are assessed for impairment at each balance date to determine whether there is any indication of impairment. If any such indication exists, the asset's recoverable amount is estimated. For the year ending 30 June 2009 there was no evidence of impairment.

(f) Comparative Figures

Comparative figures have been adjusted to conform to changes in presentation in these financial statements where required.

(g) Accounting Policies

Adoption of New Australian Accounting Standard Requirements

No accounting standard has been adopted earlier than the application date as stated in the standard. Of the new standards, amendments to standards and interpretations issued by the Australian Accounting Standards Board that are applicable to the current period, the following impact on the Foundation:

- AASB 2007-9 Amendments to Australian Accounting Standards arising from the Review of AAS s 27, 29 and 31 relocated a number of paragraphs from AASs 27, 29 and 31 substantively unamended into the following existing standards AASB 3, 5, 8, 101, 114, 116, 127 and 137.
- AASB 1004 Contributions also received a number of substantively unamended paragraphs from AASs 27, 29 and 31 following their withdrawal.

It is not expected that the relocation of AASs 27, 29 and 31 will have a material financial impact but may affect the disclosure presented in future financial reports.

Financial instrument disclosure

AASB 7 Financial Instruments: Disclosures is effective for reporting periods beginning on or after 1 January 2007 (the 2007/08 financial year) and amends the disclosure requirements for financial instruments. In general AASB 7 requires greater disclosure than that previously required. Associated with the introduction of AASB 7 a number of accounting standards were amended to reference the new standard or remove the present disclosure requirements through 2005-10 Amendments to Australian Accounting Standards [AASB 132, AASB 101, AASB 114, AASB 117, AASB 133, AASB 139, AASB 1, AASB 4, AASB 1023 & AASB 1038]. These changes have no financial impact but will affect the disclosure presented in future financial reports.

Future Australian Accounting Standards Requirements

The following new standards, amendments to standards or interpretations have been issued by the Australian Accounting Standards Board but are effective for future reporting periods. It is estimated that the impact of adopting these pronouncements when effective will have no material financial impact on future reporting periods.

- AASB 2007-8 Amendments to Australian Accounting Standards arising from AASB 101.
- AASB 2008-5 Amendments to Australian Accounting Standards arising from the Annual Improvements Project (AASB 5, 7, 101, 102, 107, 108, 110, 116, 118, 119, 120, 123, 127, 128, 129, 131, 132, 134, 136, 138, 139, 140, 141, 1023 & 1038).
- AASB 2008-6 Further Amendments to Australian Accounting Standards arising from the Annual Improvements Project (AASB 1 & AASB 5).

2. TAXATION

The Foundation is exempt from income tax by virtue of Section 50-5 of the *Income Tax Assessment Act 1997* but not from Fringe Benefit Tax and the Goods and Services Tax (GST). Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office. In these circumstances the GST is recognised as part of the cost of acquisition of the asset or part of the item of the expense.

3. NATIONAL GALLERY OF AUSTRALIA

(a) Certain expenditure incurred by the National Gallery of Australia on behalf of the Foundation has been re-charged to the Foundation.

The Foundation has received services from the National Gallery of Australia free of charge, for which a monetary value has been determined at \$254,692 in 2008/09 (2007/08: \$245,116). These services were generally administrative in nature and included employee and superannuation expenses estimated at \$92,106. All employee provisions are reflected in the National Gallery of Australia's Financial Statements.

(b) The Foundation donated \$1,087,821 in 2008/09 (2007/08: \$1,912,746) to the National Gallery of Australia to develop the national collection of works of art and to support the National Gallery of Australian and its travelling exhibition program.

- · raise money to achieve these objectives.

The Foundation operates from the Australian Capital Territory.

10. RELATED PARTY

The National Gallery of Australia has control over the Foundation as the Foundation's Constitution provides that its Board shall consist of no more than thirty one persons, of whom the Director of the Gallery, and the Chairperson and Deputy Chairperson of the National Gallery Council are ex-officio directors of the Foundation and the remaining directors of the Foundation including the Chair are appointed by the National Gallery of Australia Council. Transactions with the National Gallery of Australia during the period are disclosed in note 3 to the financial statements.

11. COMPANY LIMITED BY GUARANTEE

The Foundation is a company incorporated under the Corporations Act as a company limited by guarantee and not having share capital.

Each member of the Foundation undertakes to contribute to the property of the Foundation in the event of it being wound up while he or she is a member or within one year after he or she ceases to be a member up to the value of \$100. This payment will contribute to meeting the debts and liabilities of the Foundation as well as winding up expenses.

(d) Credit Risk

The Foundation is exposed to minimal credit risk as loans and receivables are cash and bank interest. The Foundation has assessed the risk of the default on payment and has determined that there is no need to allocate any amount to the doubtful debts account.

(e) Liquidity Risk

The Foundation's financial liabilities are payables. The exposure to liquidity risk is based on the notion that the Foundation may encounter difficulty in meeting its obligations associated with financial liabilities. This is highly unlikely due to internal mechanisms available to the Foundation (e.g. internal policies and procedures put in place to ensure there are appropriate resources to meet its financial obligations). The only outstanding payables at 30 June 2009 are for audit fees and GST which are payable within 1 year. The Foundation has no past experience of default.

(f) Market Risk

The Foundation holds basic financial instruments that do not expose the Foundation to any market risks. The Foundation is not exposed to currency, interest rate risk or price risk. In the opinion of the directors of the National Gallery of Australia Foundation:

- (1) the financial statements and notes are in accordance with the *Corporations Act 2001*, including;
 - (a) complying with the Australian Accounting Standards and the Corporations Regulations 2001; and
 - (b) giving a true and fair view of the financial position of the Foundation as at 30 June 2009 and of the performance for the year ended 30 June 2009.
- (2) there are reasonable grounds to believe that the Foundation will be able to pay its debts as and when they become due and payable.
